Please be advised that the registered equipment must comply with the Rules for the Control of Nonmetallic Mineral Processing Plants in accordance with IDAPA 58.01.01.790 through 802 (Rules for the Control of Air Pollution in Idaho). 

A representative of the Idaho Falls Regional Office will contact you regarding a meeting with DEQ to discuss the requirements of this Permit by Rule. DEQ recommends the following representatives attend the meeting: your facility's plant manager, responsible official, environmental contact, and any operations staff responsible for day-to-day compliance with permit conditions.

Other Air Quality Requirements

You will be required to submit a portable equipment relocation form each time the plant is moved to a new site of operations. DEQ requires that this form be submitted at least ten days prior to relocating the equipment. A copy of the form is enclosed for your convenience. You are also required to log the hours of operation for any electrical generator used, log all fugitive dust complaints, and log all triggers that initiate fugitive dust control. A copy of each of those forms is enclosed for your convenience.
