

Registration FAQs:

- **Is this the 2019 Water Reuse Conference? Is this the same Water Reuse Conference that I went to in 2015 and/or 2017 in Boise?**

CS Beef Packers, LLC (FULL)

CS Beef Packers, LLC began in 2015 as a partnership between Caviness Beef Packers and J.R. Simplot Company. CS Beef currently has an industrial reuse permit where they currently treat and reuse water from meat processing and meat rendering from the facility. Treatment includes screening, an anaerobic lagoon, an aerobic lagoon, and settling/storage lagoons. Reuse application includes slow rate land application during the growing and non-growing season. The tour will be about 1 hour and will include a view of some of the in-house meat processing, a visit to the reuse land application site, and discussion of the drinking water and wastewater treatment system.

Twenty Mile South Farm

Twenty Mile South Farm (TMSF) is a 4,225 acre farm that is owned and operated by the City of Boise. This farm receives Class B biosolids from Lander Street and West Boise Water Renewal Facilities to be stored and applied to farm soils as a fertilizer to produce crops. Each facility treats used water from domestic and industrial sources. The three main crops (corn, alfalfa, and winter wheat) are harvested and then sold to local farmers. In 2014, TMSF was awarded by the Northwest Biosolids and the Pacific Northwest Clean Water Association the Excellence in Biosolids Management Award. TMSF has also recently constructed a new office and maintenance facility that is Idaho's first zero-net energy facility. The tour will be about 90 minutes and you will see how the City of Boise sustainably manages 30,000 wet tons of biosolids per year including transportation, storage, application, and the process of operating the largest contiguous farm in Ada County, Idaho.

Lander Street Water Renewal Facility (Full)

Lander Street Water Renewal Facility (WRF) was built in 1948 and has expanded to meet the city of Boise's needs since. Currently, the WRF treats on average about 10-12 MGD and treats domestic and industrial wastewater. This WRF produces Class B sludge that is transferred to West Boise WRF where it is dewatered and sent to Twenty Mile South Farm (TMSF). TMSF then applies the biosolids to foraging crops and sells the crops to local farmers. The tour will be about 90 minutes and you will see one of the first activated sludge plants in the northwest, original methane driven engine pumps, inline activated primary fermenters, innovative EBNR step feed aeration basins, secondary clarification, UV disinfection, and daily process monitoring lab testing.

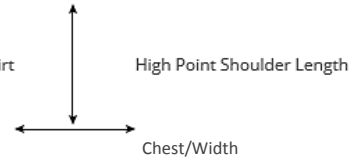

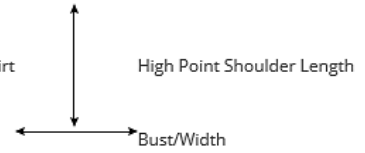
